Resolutions on War Against Iraq

I. WHEREAS, the Bush Administration has not demonstrated it has explored all means short of war to reach a peaceful settlement of disputes with the leadership in Iraq; and

Whereas, reputable voices (such as that of former weapons inspector Scott Ritter) have been raised contradicting claims an all-out war with Iraq is called for; and

Whereas, unthinkable and unacceptable human and environmental devastation could result, either from a conflagration involving oil (by Saddam Hussein, as in 1991) or from deployment of nuclear or other radioactive weapons (by the United States, as in the depleted uranium used in central Europe and in Iraq, and as in new nuclear weapons being readied that bury themselves in the land); and

Whereas, no feasible plan for Middle East peace is going forward while war with Iraq is being threatened, but rather hostility toward the United States is escalating among U.S. allies, including Iraq's neighbors; and

Whereas, no persuasive plan for reconstruction after such a war has been brought before the U.S. Congress and the American people, who presumably would help pay for it;

NOW, THEREFORE, in keeping with its standing policy, the IVI-IPO denounces the proposed use of first-strike weapons, and **calls on its representatives in Congress to vote against the Administration's plans;** and

Further, also in line with its standing policy, the IVI-IPO condemns all covert military actions, including attempts to overthrow the government of Iraq, and **calls on members of Congress to do the same, and to demand a civil, open, and peaceful resolution to all disputes.**

To implement this resolution, the IVI-IPO will communicate it through its chapters and other means to all IVI-IPO members, and they are urged to act upon it by contacting their representatives without delay. Members who wish may contact the National Affairs chair for news of activities on this issue.

II. The IVI-IPO endorses the Iraq Peace Pledge now being circulated by the Campaign of Conscience and urges its members to participate.
